


# Where, and how, does LABEL ARCHIVE fit into my network?

LABEL ARCHIVE lets you secure your labels at the server level. It fits perfectly in any production environment using CODESOFT. It can work alongside SENTINEL to give you an added layer of traceability to your label printing and print management system.

LABEL ARCHIVE includes Server, Client and Web modules for a complete and secure label printing system:

- LABEL ARCHIVE Server The Server module typically runs on a server machine as a centralized database, driven through a Windows® service. It allows administrator-level users to configure user management and messaging systems, as well as set up all label approval, archiving and security preferences.
- LABEL ARCHIVE Client The Client module is an add-on to the Label Designer application (CODESOFT). It connects to the Server module to give authorized users the ability to perform document management activities (Check In, Check Out, Print History, Version Control, Reprint, etc.) from within the Label Designer application.
- LABEL ARCHIVE Web The Web module allows remote users (or customers) to connect to the Server via a Web browser and perform basic functions including requesting a new label design, approving existing label designs, and viewing full label print history records.


